Progressive Discipline Plan

To develop an environment that is safe and conducive to learning, Kenwood K-8 Center adheres to the M-DCPS Code of Student Conduct. We believe in increasing student achievement and creating a safe learning environment through the implementation of a *progressive discipline plan* that affords students an opportunity to correct behaviors that prevent success. Kenwood K-8 Center's Progressive Discipline Plan was developed to help students and their parents understand the consequences for the most common violations of The Code of Student Conduct. This list is not all-inclusive, and a student committing an act of misconduct not listed will be subject to administrative disciplinary actions at the discretion of the Principal or his/her designee. LEVEL I Violations are acts that disrupt the orderly operation of the classroom, school functions, extracurricular activities or approved transportation.

Violation of Dress Code (Per 9-Week Period)

1 st - 2 nd	Verbal warning/change to uniform
3 rd	Detention
4 th	Referral*/Parent Contact/Saturday School
5 th - 8 th	Referral*/Parent Contact/School Center for Special Instruction (SCSI)
9 th +	Referral*/Parent Contact/Outdoor Suspension 1-10 Days

Trespassing

1 st	Verbal Warning
2 nd	Referral*/Parent Contact/Saturday School
3 rd	Referral*/Parent Contact/School Center for Special Instruction (SCSI)
4 th +	Parent Contact/ School Police

Unauthorized use of electronic devices

1 st	Devices will be confiscated
2 nd +	Devices will be confiscated and will only be returned to parents
